These documents should reach the office of the Ag. Board Secretary, Kisii County Public Service Board, on or before **Monday 20<sup>th</sup> November, 2024**.

Applications should be submitted in a sealed envelope with the position applied for marked on the left side and either hand delivered to the reception desk at the Kisii CPSB offices situated at Kisii –Kilgoris road near the Kisii Cathedral junction road or posted to the following address:

**Important information to all applicants:**

Short-listed candidates shall be required to:

- 3) In addition, they will be required to ensure that the Head of Department's recommendation is forwarded before the interview.
